**WHEREAS**, the Waterloo Days Committee has approached the board with a desire to have pony rides; and


**WHEREAS**, LaRue's Little Horse Ranch Pony Rides has submitted a contract at a cost of \$700 to have pony rides for the Village.

**THAT**, the contract with LaRue's Little Horse Ranch Pony Rides, attached hereto as Exhibit "A", is hereby adopted.






